

1. The agency shall submit Xerox copy of valid Trade License, GST & P.TAX, at the time of application.
2. The Rate for Use of Urinal @ Rs. 1.00 per head.
3. The agency should maintained Toilet complex are to be keep clean and hygienic condition with renovation works as & when required.
4. Electric meter shall be installed at the instance of Asansol Municipal Corporation but electricity charges shall be payable by the agency.
5. If for any reason, electricity charges are not paid & the electric connection is cut off, the agency shall have the liability to pay outstanding electricity charges & reconnection charges. In any case the Corporation shall have no liability in it.
6. The agency shall not transfer, mortgage, lease, let out or in any way part with possession of the scheduled property to any THIRD PARTY under any circumstances.
7. The cost of supply of water shall be paid by the agency. Asansol Municipal Corporation shall have no liability / responsibility for the same.
8. The agency shall not claim any right, title or interest in respect of the schedule premises.
9. The agency should allow the schedule premises to be inspected by any officer /employee of the Asansol Municipal Corporation.
10. The memorandum of Agreement shall be effective for a period of 15 (fifteen) years which may be renewed thereafter on terms and conditions to be determined/ agreed upon both the parties.

11. If, for any reason, after expiry of the first year, the agency fails to deposit the amount paid for the second year within 7 (seven) days thereafter, the Corporation shall have the discretion to terminate this agreement and call for fresh Tender.
12. The agency shall not allow any type of illegal activity within the schedule premises.
13. The Corporation reserves the right to cancel this Memorandum of Agreement if the Agency fails to comply with the terms conditions of this Memorandum of agreement. In this case the security/caution money deposited by the agency will be forfeited.
