NE: - (i) Intending Tenderer will not have to pay the cost of tender documents for the purpose of participating in tendering, but the successful L1 (Lowest) Bidder will have to pay the cost of tender documents of 2 (two) sets @ price mentioned in the list of scheme of NIT during purchase of tender documents for execution of agreement as per notification no. 199 Ch. C/2M-10/2012 dated 21/12/2012 of the Secretary, Public Works Department, CRC Branch, Government of West Bengal. In case of any contractor (L1) expressed his / her willingness to have extra copy of the standard contract forms, only one spare copy of standard contract form may on payment of prescribed price be supplied to a contractor or firm of contractors, eligible to tender in a specific work on receipt of written requisition well in advance for the same.
