With reference to tender Notice No. 353/PW/ENG/21 Dt:- 1/12/21 and Ref:- 1st Corrigendum Vide No.:- 1311/PW/ENG/21 dt:- 10/12/21 and 2nd Corrigendum Vide No. 1311/PW/ENG/21 Dt:- 13/12/21 the following additional changes are made:-

- 1) Rate to be quoted per SQFT per day per lot instead of per parking lot per day.
- 2) The area of each parking lot will be specified at the time of issue of license.
- 3) Rate to be collected from keepers (inclusive of all taxes) are as mentioned below
 - i) Cycle – Rs 2.00 per entry for three hours
 - ii) Motor cycle/Scooter – Rs 4.00 per entry for three hours
 - iii) Car – Rs 10.00 per entry for three hours
 - iv) Taxi/Auto/TOTO – Rs 10.00 per entry for three hours
 - v) Mini Truck For loading & Unloading purpose : Rs 30.00 Per entry (10 Pm to 8 AM) Only at Night
 - vi) Truck (6 Wheeler) For loading & Unloading purpose : Rs 60.00 Per entry (10 Pm to 8 AM) Only at Night
 - vii) Truck (More than 6 Wheelers) For loading & Unloading purpose : Rs 100.00 Per entry (10 Pm to 8 AM) Only at Night

Be it mentioned here that additional charges (inclusive of all taxes) beyond initial three hours to be paid by the keepers at the following rate for every additional three hours.

- a. Cycle – Rs 2.00 per the period of every additional three hours
- b. MotorCycle – Rs 4.00 per the period of every additional three hours
- c. Car /Taxi – Rs 10.00 per the period of every additional three hours
- d. Auto Rickshaw/ TOTO – Rs 10.00 per the period of every additional three hours

Rate beyond the above mentioned rate should not be collected from the keepers in any circumstances.

- 5) Last date of issue of tender paper from Cash Section :- 21.12.2021 instead of 16.12.2021 upto 2.00 P.M.
- 6) Last Date of submission of duly filled tender paper : 22.12.2021 instead of 17.12.2021 upto. 2.00 P.M.
- 7) Date of Opening of tender on : 22.12.2021 at 3.00 P.M. instead of 17.12.2021 at 3.00 P.M.
